Please Support our Newsletter Advertisers The West Colfax Avenue Overlay District Focus Group has been meeting to discuss urban design issues as part of the implementation to the West Colfax Avenue Action Plan. Its goal is to revise the overlay district language to allow and encourage the development of a more pedestrian-friendly streetscape, as well as allow for mixed-use and residential buildings along Colfax Avenue.

The topics discussed so far include signage, streetscape, inclusion of pedestrian zones and amenities, and appropriate building heights. In November the group discussed ways to connect the Garrison Street light rail station to Colfax Avenue, both visually and physically. The Focus Group expects to complete its work in late spring of 2008.

The next Focus Group meeting is scheduled for 6:30 p.m. on December 6 in the 2<sup>nd</sup> floor Public Works Conference Room. If you are interested in the future of Colfax and its effect on our neighborhood, please plan to attend. The agenda is expected to include continued discussion of the Garrison light rail station connection to Colfax, and review of draft overlay district language. ### Black Walnut Trees at Risk

As a well acclimated and hearty tree, black walnuts shade many Eiber homes and keep many squirrels busy with their delicious nuts each fall. But this treasured and valuable tree is at risk due to a fast moving insect known as the Walnut Twig Beetle. Unlike many insect infestations that can be warded off simply by keeping one's trees healthy (with proper care including fertilizer and water), this beetle attacks healthy and stressed trees with the same sad outcome. Not only does the beetle attack the tree, it also spreads a fungus, similar to how Dutch elm disease is spread by the elm bark beetle. So what can we do to protect our beautiful trees? First, if you suspect your black walnut is impacted call a specialist right away and have it removed (including all the wood) if the beetle is found. This is the best way to stop the spread of the beetle and fungus. To protect healthy trees, there is a recommended soil-injected pesticide that has been helpful in prevention and control (though there are no guarantees even with the treatment). 
## FEDERAL CENTER UPDATE – WHAT'S UP?

- Sept 19, 2007 General Services Administration (GSA) sold 65 acres to the City of Lakewood, which in turn sold the land to St Anthony West for its new facility and to RTD for a bus/light rail station.
- Mid Oct 2007 GSA finished its new boundary fence marking the border with its new neighbors, RTD and St Anthony's.
- Oct 19, 2007 With a ribbon-cutting ceremony St Anthony West Hospital celebrated the start of development, with construction to start early in 2008 and finish in 2010. Some clinical services are likely to be provided at its current location on Colfax.
- Oct 2007 GSA completed the Master Site Plan for the Denver Federal Center's next 20 years. The plan includes a mix of land use districts centered on a "Federal Quad," with higher-density development at the northern and western edges, tapering to lower-density along Alameda and Kipling, and integrating new development with existing uses. Natural systems and open spaces will be preserved.
- Nov 2007 The Final Master Site Plan and Environmental Impact Statement will be reviewed by the public. Washington's approval of the plan is expected in early January 2008.

After that, GSA will be able to start implementing the plan. Although the plan is a long-term vision and will occur in stages over the course of twenty years, it sets forth a clear and exciting strategy and framework for meeting the current and future needs of both the Federal tenants and the larger community.

# Where Light Rail and a Police Facility Might Meet

After a diligent search for a building the Lakewood Police Department may have found a new home-to-be for storing property and evidence. The rented storage building on 8<sup>th</sup> Ave near Quail St is not big enough for the growing amount of property required to be kept for unresolved crimes or for cases that might be appealed. A building owned by the City would not only provide needed space, but also save money and could be adapted for specialized storage such as DNA evidence.

The probable new home is an industrial warehouse at 1290 Harlan St, right next to the West Corridor Light Rail line! It would be one of the first buildings that riders of light rail would see in Lakewood. Residents of Two Creeks Neighborhood are delighted at the prospect, saying that a renovated storage facility at that site would be a wonderful improvement. The Police Department still needs to complete its "due diligence" research to be sure the property is safe and can be renovated within its budget of \$1.2 million. In the future the site might also be appropriate for a neighborhood police station.



# **Neighborhood Grant Update**

Several concerned Eiber neighborhood residents put forward a variety of requests and ideas for the board to consider as we prepared our grant request to the City of Lakewood as part of the Neighborhood Participation Program. Thank you to everyone who submitted ideas! For those suggestions which were not selected for submission this time, the board is reviewing them to determine other avenues to meet the needs and will be in touch with the submitters as next steps are determined. The two requests which were put forward by the Eiber board include an 'active' speed sign (which flashes each car's speed as it goes by encouraging traffic to slow down) on Garrison Street between 10<sup>th</sup> and 14<sup>th</sup> streets and port-a-potty placement in Holbrooke and Ritchey parks in Lakewood (with permanent attractive screening around them) to provide park visitors convenient facilities during the busy summer months. These two proposals are under review by the City now and we expect details as to the outcome by the end of the year. Look for future reports on this and other Eiber pursuits for neighborhood improvements in coming issues and thanks again for your support and feedback!

# **Graffiti Reporting**

There has been a change in the graffiti reporting process. There are two options to report graffiti, file a report on-line or call the police non-emergency number.

- Online graffiti reporting --"Click the Green Stripe at Lakewood.org" and then select the "Report Graffiti". This is the quickest and easiest way to get to the online reporting form.
- The Communications Center non-emergency number is 303-987-7111.

This change in procedure has been made to eliminate multiple reporting points that were previously used by citizens (Police Department, Code Enforcement, Hotline, etc.)
